All withdrawals from accounts are subject to a fee of \$60, plus applicable taxes, which is deducted from the net amount withdrawn. All transfers out of accounts are subject to a fee of \$150 plus applicable taxes.

NSF Cheques:

Open Access may apply a charge of \$25 for NSF cheques.

Annual rates are subject to GST or HST as appropriate and are applicable to all assets in each plan; fees will be calculated and payable at each calendar month, or quarter, or at the time of withdrawal (unless paid directly out of the assets of the fund) based on the average daily or month-end net asset value of the investments held by the plan during the period. The maximum fees from dollar 1 are quoted; as assets increase for Open Access' entire client base, these fees will decline. These fee savings will be passed on to the members.
